We've been down at Benning visiting the old Post. It looks some different. However, none of us stayed over. Enough was enough. We did not get to check out the chow. We were supposed to eat in a Ranger Mess Hall but somebody beat us to it and burned it down two days before we were due.

#### General Business Meeting Saturday August 8, 2003

The Meeting was called to order by Historian/Reunion Chair Passanisi at 12:20 p.m.

#### **REPORT OF OFFICERS:**

Reunion Chairman's—Robert Passanisi reported that in spite of the preliminary trouble he had with the Valley Forge Hilton Hotel management, in the end they did an excellent job and last year's reunion was a great success.

#### President—Phil Piazza

His report is as stated in the latest Burman News. He spoke on the Marauders at an 8-part symposium at a local college and was asked to repeat it. He also mentioned contacts with CNN cable TV to include the Marauder history in a future series.

#### Vice President—JACKSON POKRESS

Pokress reported that, he gave a number of talks on the Marauders in his area. He found that many people knew little or nothing about the Marauders and that talks at the schools were most interesting.

#### Executive Secretary - Raymond Lyons

Last years reunion donations were \$3,945.

Expenses for the Fiscal year 2002 were \$13,751.48, for 2003 were \$9,686.09.

We sent out 882 pieces of mail at a cost of \$1,400.49 and 6,594 copies of the Burman News. We purchased 25 copies of Mars Men in Burma for \$594.21. The 124th TX NG also purchased a larger quantaiaty for their members as a joint purchase to obtain a lower price for both of us. Total receipts from donation and sales were \$12,953.89. The donations in the last year have increased, especially from honorary members. We received two \$1,000 donations, one member has been doing it for a number of years and the other from an Honorary came as a wonderful surprise. The Exc. Sec. Checkbook balance as of August 4, 2003, was \$3627.98.

I went to China as the MMA representative for the re-opening of the Marauder exhibit at the Stilwell museum at my own expense because Treasurer Herbert Clofine refused to reimburse me. This matter came up at the last minute and between traveling to LA to get my Passport renewed and a Chinese Visa attached, we did not think to get prior approval of expenses by MM Officers. Dave Quaid and Dave Richardson were aware of my proposed travel.

Note from Bob Passanisi- It should be stated that Treasurer Clofine didn't approve the expense before Lyons went to China because he lacked the authority to approve that large an amount without agreement of the required number of Executive Committee members. The required number of Executive Committee members has since agreed to reimburse Lyons the amount of \$850 towards his expenses of \$1519 for airline and hotel expenses.

Tony Colombo was not present at this reunion for the first time in many years. It was brought to the attention of the membership as to what Tony Colombo had done for this association. Tony Colombo had an attorney draw up the Constitution & by-laws, had the Association Incorporated, got us tax exempt status and started the newsletter.

#### Historian – Bob Passanisi

Passanisi reported that the website has been in service for more then 5 years and has had more then 60,000 visitors. He posted more then 250 photos with captions that haven't been posted before. He has also begun arrangements to address classes in local schools on the Marauder's experiences in World War II.

Passanisi said that he has developed a method to convert our black and white Burma photos to color photos. He has converted six so far, enlarging and mounting them. He intends to do all of the important ones and is looking for a cost-effective way of enlarging and mounting them. It takes more then an hour just to piece a four-part photo together and mount it. Passanisi stated that because of a number of requests from members of Mars Task Force Men and their descendants, he has started work on a MTF webpage. He said that working a webpage takes an enormous amount of time.

#### Historian Emeritus—Not present.

#### Liaison Officer - Dave Richardson

He has been in close contact with The National Museum of the Pacific War and Nimitz Foundation. This organization holds a symposium each September on some phase of the Pacific war. In the past, the symposium at Admiral Nimitz's birthplace strongly favored Navy and Marine operations throughout the Pacific. Richardson said that in serving on a panel of war correspondents at a previous symposium, he emphasized a need to give corresponding attention to the Army's role in winning the war. One result is that this year's symposium will be on "The Forgotten Warriors of China-Burma-India." Richardson stated that he was given a major part in planning the event and obtaining speakers. Three of the speakers will be Marauders: Dr. Jim Hopkins, Grant Hirabayashi and himself. The symposium will be a two-day event.

#### **SHARING THE STORY**

Dear Robert:

Thank you for including me on your list of addressees for the Weston e-mail. I have not responded to Mr. Cress B. Johnson's comments regarding Logan, and now--based upon the advice in your second e-mail--I do not intend to. I do have several comments for the historical record, however, for use in any fashion you may wish.

To the point: Logan Weston was one of the three bravest men I ever knew in the course of my 37 years of military service. By just about any measurement one can apply, he was arguably the most capable and effective company grade officer in all of Galahad. I would make the case that he clearly earned the Distinguished Cross at least twice during the North Burma Campaign--the first time during the battle at Walawbum, the second time during the prelude to the battle for Nhpum Ga. In the latter instance, Weston's skillfully conducted rearguard actions covering the retreat of the 2d and 3d battalions from the Inkangahtawng area prevented without a doubt what otherwise would have been a true debacle spelling the lend of the Marauders as an effective combat unit.

Logan and I were best friends. I would maintain that he and I had the two best I & R platoons in the outfit. He was roughly eleven years my senior, far more experienced, mature and combat-wise than I, and I looked up to him almost as a leadership icon and never ceased to learn from him. I saw early on that there were several sides to his nature. He was a man of strongest faith, deeply dedicated and devoted to his Lord. In private and under non-stressful conditions, he was quiet-spoken, almost shy, and ever considerate of those around him. When the shooting began, his whole demeanor, voice and gestures would change, and he would become a man of fire with blazing eyes--yet under complete control, concerned only with destroying the enemy and guiding and protecting his men. He epitomized the effective small unit combat leader; I have cited him many times in my classes of instruction as a classic leadership model.

What probably is not known to many is that Logan, COL Hunter and I—all three--were separately invited out to Hollywood in the summer and fall of 1960 to consult with representatives of Warner Brothers, who had bought the screen rights to Charlton Ogburn's book and were making preparations to begin filming. For

whatever reason, I was the one whom they asked to serve as technical advisor. At the time I was serving as the Director of Instruction of the Army's Special Warfare School at Fort Bragg, where I had just completed writing a special course on Counter-Insurgency Operations that was attracting a lot of attention from higher-up and was being scheduled for its pilot run.

My boss at Bragg agreed to release me for six months to work with Warner Brothers on the condition that I find a suitable replacement to run this important course in my absence. And who do you think agreed to take my place? My loyal and selfless friend, then-LT COL Logan E. Weston.

We should all salute his memory.

### CITATION FOR LT COL MELVIN R BLAIR

Lieutenant Colonel Melvin R Blair is inducted into the Ranger Hall of Fame for displaying exceptional valor in two wars. He enlisted in the Army in 1934 and served in the 13th Horse Cavalry Regiment at Fort Riley KS, until

assigned to the Cavalry ROTC unit at Norwich University, Northfield VT. In 1942, he was commissioned upon his graduation and served as a platoon commander in the 10th Horse Cavalry Regiment at Camp Lockett, California.

In World War II, he volunteered for Merrill's Marauders and, upon arriving in Burma, was assigned as a reconnaissance platoon leader in the 209th Combat Engineers. When a patrol under his leadership was pinned down by machine gun fire, he crawled alone to the rear of the enemy position and killed the enemy gun crew with his carbine. Three days later, when two members of his patrol were wounded, he crawled out under heavy enemy fire and brought them back. He earned a battlefield promotion to captain and was appointed the Executive Officer of the 3rd Squadron, 124th Cavalry Regiment. Shortly thereafter, he was wounded by enemy action but rejoined his unit in China. Following World War II, he attended the Army Command and General Staff College Fort Leavenworth Kansas; Armor School and the G-2 course at Fort Leavenworth. He then went to the G-

2 staff at General Headquarters, Tokyo.

During the Korean War, he served as a battalion commander in the 25th Infantry Division. After one of his companies lost all but one officer to enemy fire, he took over. He led one platoon in a successful counter-attack; organized a perimeter defense with 50 men; and inspired them by word and deed to hold the position, despite four Banzai attacks by more than 400 enemy soldiers. With ammunition running out, he ordered the withdrawal of his unit while personally guarding its rear with six men. Although wounded, he remained until sure that the main body and other wounded were able to withdraw safely.

After his recovery, he held assignments in the Pentagon, Fort Bragg and Fort Benning and retired from military service in 1954. For extraordinary heroism in two wars, he was awarded the Distinguished Service Cross, with Oak Leaf Cluster; the Silver Star; the Bronze Star, with 2 Oak Leaf Clusters; the Purple Heart, with two Oak Leaf Clusters; and the Combat Infantryman Badge with Star.

#### LTC MELVIN R BLAIR, Acceptance speech.

Thank You, Executive Board, Ranger Hall of Fame, Merrill's Marauders Association, Fellow Rangers, Distinguished Guests, Ladies and Gentlemen.

I stand here today, humbled and overwhelmed, to receive induction into the U.S.ARMY RANGER HALL OF FAME. I proudly accept this honor solely on behalf of my fellow Rangers who died in the jungles, rice paddies and mountains of Burma in World War II In death they remain an inspiration for those of us who survived that terrible war in that fearsome environment, beset by a clever vicious enemy force of Japanese troops who sought haven in their heaven rather than surrender when surrounded. And our Rangers, ravaged by malaria and fatigue, carried on, often without adequate military supplies and rations, and when wounded or ill, transported to distant medical aid facilities by ox cart. To have known and served with our Rangers was the greatest privilege of my life. They fought and perished while leading the advance combat elements of their units into enemy territory. Thus allowing those of us here today to fight on to victory and to return safely home.

Those brave Rangers, who fell there, in faraway places with strange sounding name, are with us today, in spirit and in our hearts. It behooves us with what time we have left to do everything in our power to uphold their high standards, preserve their integrity and build on their achievements and ultimate sacrifices.

I am writing about my dad, Col. Logan E. Weston (The Fightin' Preacher), 5307/3/OCT/I&R Plat Leader, age 89, who peacefully went to be with our Lord on May 5, 2003. He could have been buried at Arlington National Cemetery with full honors, but he would never consider it. He always insisted he "was no hero." I disagree. He was my champion and more importantly, my precious dad. He was an example of the good that can result when an ordinary man submits his life to our extraordinary, awesome, living God.

In his last 2 days, he saw and counted angels, or as he called them, "translucents." He dedicated his life to "make a difference" and to live for the Glory of God. In and out of consciousness, he was fighting "his last defensive battle" to protect his men from the enemy. How he loved you!

My family and I were unsure if we should attend this year's reunion in Georgia because we are all still adjusting to such a great loss. Sometimes his death hits us hard and other times it seems like it has not even begun to sink in. We have all wept so much and been through a lot this year. I am so thankful we did attend. It was inspiring. The healing that we received through the remembrance and respect given to Dad was unexplainable. Everyone was so kind, reverent, and considerate to us. This is something our family will never forget. The more we were around you the more we were comforted, strengthened and renewed. Words cannot express how much we were moved and rescued by your shining love, beautiful words, and prayers.

Merrill's Marauders are among our nation's most excellent heroes: paramount, unmatched, and in short, amazing. It is staggering to me to know such living legends. One of the reasons the Marauders were victorious against all odds is because they fought, sacrificed and overcome as one. The incredible family bond of unified commitment is as strong and motivating today as it was 60 years ago. Although Dad is not physically with us, I felt his spirit and saw him in the courageous face of every Marauder and Ranger. He lives in our hearts and minds. The way you so beautifully treated my family was not only a tender tribute to Dad but it mirrored the enormous admiration and strength earned and shared between every Marauder.

Marauders, thank you for the legacy you left us. You have such good hearts and immense bravery. It was your volunteering, unparalleled valor, devotion, and for suffering such horrors of war so that we may live in freedom today. May your heroism and sacrifices never be forgotten or taken for granted. "He is my strength and song in the heat of battle, and now He has given me the victory. The strong arm of the Lord has done glorious things. I shall not die, but live to tell of all his deeds." Ps. 118: 14, 16, 17.

Dad distinguished himself as an incredible warrior for God and Country, serving with humility and unwavering dexotion. He touched and inspired many lives. His faith and zest for life was contagious. One of the last things Dad said to me was to "Trust God. Walk with Him daily". I want to try to be like him - as a Second-Generation Marauder. I think he would like this.



#### **EDITOR:**

I have a suggestion about Marauders who have uniforms, equipment, etc that they do not know what to do with. I have recently had an experience selling a relative's WW II uniform and equipment on the ebay system. It was a surprise to me to find out there is a big market for such items and significant money shows up for the offering. It should certainly be a factor when MM men or widows make such an offer. It is a complicated system to establish yourself on the e-bay market but worthwhile. You need to open an account with E-bay or a similar internet auction. If you want to allow your customers to use a credit card, then you have to sign up with Paypal or some other financial institution. You can limit payment to check, money order or cash but I think you get more sales offerings if you can use credit cards. Look at "completed items" for your category.
