

# STUDIO MOO PRIVACY POLICY

## 1. OUR POLICY

Welcome to STUDIO MOO Inc. (“STUDIO MOO”, “we”, “us” and/or “our”). This privacy policy (this “Privacy Policy”) has been created to provide information about our company, its video sharing and how we collect, use, share and protect information in relation to our mobile services, web site (the “Site”), and any software provided on or in connection with STUDIO MOO services (collectively, the “Service”) to our users (“you”, “your”) and your choices about the collection and use of your information, including personally identifiable data (“Personal Data”). By using our Service you understand and agree that we are providing a platform for you to post content, including photos, comments and other materials (“User Content”), to the Service and to share User Content publicly. This means that other Users may search for, see, use, or share any of your User Content that you make publicly available through the Service, consistent with the terms and conditions of this Privacy Policy and our Terms of Use (which can be found at <https://goo.gl/bTZSwJ>) (the “Terms”). You must agree to the Terms prior to using the Service or any features or functionality available through the Service. By using the Service you confirm that you agree to these Terms. If you do not agree to these Terms do not use the Site.

## 2. INFORMATION WE COLLECT

When you interact with us through the Service, we may collect Personal Data and other information from you, as further described below: **Personal Data That You Provide Through the Service:** We collect Personal Data from you when you voluntarily provide such information such as when you register for access to the Service (for example, name and email address), use certain features of the Service, contact us with inquiries or respond to one of our surveys. By voluntarily providing us with Personal Data, you are consenting to our use of it in accordance with this Privacy Policy. If you provide Personal Data, you acknowledge and agree that such Personal Data may be transferred from your current location to the offices and servers of STUDIO MOO. **Non-Identifiable or Aggregated Data:** When you interact with STUDIO MOO through the Service, we receive and store certain non-personally identifiable information (for example, geo-location and device ID). Such information, which is collected passively using various technologies, cannot presently be used to specifically identify you. STUDIO MOO may store such information itself or such information may be included in databases owned and maintained by STUDIO MOO. In addition, we may collect information about your use of our Site and Service such as your IP address, browser information, page visitation history, crash diagnostic reports, device information, computer information, usage pattern information, operating system information, location information, timestamp information and any other anonymous information about the nature and frequency of your use of our Site and Service. In operating the Service, we may also use a technology called “cookies.” A cookie is a piece of information that the computer that hosts our Service gives to your browser when you access the Service. Our cookies help provide additional functionality to the Service and help us analyze Service usage more accurately. For instance, our Service may set a cookie on your browser that allows you to access the Service without needing to remember and then enter a password more than once when you are using the Service. On most web browsers, you will find a “help” section on the toolbar. Please refer to this section for information on how to receive notification when you are receiving a new cookie and how to turn cookies off. We recommend that you leave cookies turned on because they allow you to take advantage of some of the Service’s features.

## 3. OUR USE OF YOUR PERSONAL DATA AND OTHER INFORMATION

If you provide Personal Data for a certain reason, we may use the Personal Data in connection with the reason for which it was provided. For instance, if you contact us by email, we will use the

Personal Data you provide to answer your question or resolve your problem. Also, if you provide Personal Data in order to obtain access to the Service, we will use your Personal Data to provide you with access to such services and to monitor your use of such services. STUDIO MOO may also use your Personal Data and other personally non-identifiable information collected through the Service to help us improve the content and functionality of the Service, to better understand our users and to improve the Service. We may use this information to communicate with you regarding the Service or to tell you about services that we believe will be of interest to you. If we do so, marketing communication we send you will contain instructions permitting you to “opt-out” of receiving future marketing communications. Note however that as a user of the Service you cannot opt-out of some administrative communications that are reasonably necessary to the Service, such as billing or service notifications.

#### **4. OUR DISCLOSURE OF YOUR PERSONAL DATA AND OTHER INFORMATION**

STUDIO MOO is not in the business of selling your information. We consider this information to be a vital part of our relationship with you. There are, however, certain circumstances in which we may share your Personal Data with certain third parties without further notice to you, as set forth below:

**Business Transfers:** As we develop our business, we might sell or buy businesses or assets. In the event of a corporate sale, merger, reorganization, dissolution or similar event, Personal Data may be part of the transferred assets.

**Agents, Consultants and Related Third Parties:** STUDIO MOO, like many businesses, sometimes hires other companies to perform certain business - related functions. Examples of such functions include mailing information, maintaining databases and processing payments. When we employ another company to perform a function of this nature, we only provide them with the information that they need to perform their specific function.

**Legal Requirements:** STUDIO MOO may disclose your Personal Data if required to do so by law or in the good faith belief that such action is necessary to (i) comply with a legal obligation, (i i) protect and defend the rights or property of STUDIO MOO , ( iii) act in urgent circumstances to protect the personal safety of users of the Service or the public, or (i v) protect against legal liability.

#### **5. EXCLUSIONS**

This Privacy Policy does not apply to any Personal Data collected by STUDIO MOO other than Personal Data collected through the Service. This Privacy Policy shall not apply to any unsolicited information you provide to STUDIO MOO through the Service or through any other means. This includes, but is not limited to, information posted to any public areas of the Service, such as bulletin boards, any ideas for new products or modifications to existing products, and other unsolicited submissions (collectively, “**Unsolicited Information**”). All Unsolicited Information shall be deemed to be non-confidential and STUDIO MOO shall be free to reproduce, use, disclose, distribute and exploit such Unsolicited Information without limitation or attribution.

#### **6. CHILDREN**

STUDIO MOO does not knowingly collect Personal Data from children wider the age of 13. If you are under the age of 13, please do not submit any Personal Data through the Service. We encourage

parents and legal guardians to monitor their children's Internet usage and to help enforce our Privacy Policy by instructing their children never to provide Personal Data through the Service without their permission. If you have reason to believe that a child under the age of 13 has provided Personal Data to STUDIO MOO through the Service, please contact us, and we will endeavor to delete that information from our databases.

## **7. LINKS TO OTHER WEB SITES**

This Privacy Policy applies only to our site and the Service. Our Site and our Service may contain links to other web sites not operated or controlled by STUDIO MOO ("Third Party Sites"). If you click on a link to a Third Party Site or product when using our Site or Service, you will leave our Site and Service and go to the Third Party Site or product you selected. If you choose to provide your information directly to Third Party Sites and products, your information will be governed by the policies of those Third Party Sites and products and STUDIO MOO shall have no liability or responsibility for the privacy practices or other actions of any third party website or service.

## **9. SECURITY**

STUDIO MOO takes reasonable steps to protect the Personal Data that we collect and maintain. We follow generally accepted industry standards to protect the Personal Data submitted to us, both during transmission and once we receive it. When you enter sensitive information (such as a credit card number) on any form supplied to you by STUDIO MOO Inc., we encrypt that information using secure socket layer technology (SSL). However, no Internet, email or other electronic transmission is ever fully secure or error free and while we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.
