END USER LICENSE AGREEMENT

IMPORTANT: PLEASE READ THIS LICENSE CAREFULLY BEFORE USING THIS SMARTPHONE APPLICATION (SOFTWARE).

1. LICENSE

By receiving, opening the file package, and/or using the My Society App ("Software") containing this software, you agree that this End User License Agreement (EULA) is a legally binding and valid contract and agree to be bound by it. You agree to abide by the intellectual property laws and all of the terms and conditions of this Agreement.

Unless you have a different license agreement signed by Aditya Nayak, your use of the My Society App indicates your acceptance of this license agreement and warranty.

Subject to the terms of this Agreement, Aditya Nayak grants to you a limited, non-exclusive, non-transferable license, without right to sub-license, to use the My Society App in accordance with this Agreement and any other written agreement with Aditya Nayak.
