Please be aware that NFPD gives priority for ride-along requests to individuals currently testing with NFPD and individuals interested in or pursuing a career in firefighting and/or a medical field. Due to the nature of unpredictable calls, NFPD does limit requests. **Please fill out the information below and return your request form in person at the Administration Office** (address above) M-F 9 am - 5 pm. You will hear back from NFD personnel to schedule a ride-along if your request is approved. Please allow 2 weeks for processing.

## **INSTRUCTIONS - IF APPLICATION APPROVED**

An applicant (now also referred to as an "observer") must agree to the following instructions and sign a hold harmless agreement. Nampa Fire Protection District reserves the right to add any additional instructions or stipulations to the is agreement at any time.

Your basic role as a ride-along "observer" Instructions: #1) Remain in or return to the Fire vehicle when instructed to do so by the Company Officer or Crew, #2) Comply with all directions given by a Company Officer or Crew, #3) Do not operate equipment or Fire vehicle unless you receive a Company Officer's permission, #4) Be an observer. The Nampa Fire Protection District will not be liable for a ride-a long's unauthorized participation. #5) You may be asked to wear a surgical or N-95 style mask while at the station or on emergency scenes for your protection and that of the citizens we serve. #6) All patient information observed or witnessed is considered confidential. Observers are not allowed to share patient information of any type with people not involved at the incident scene. #7) Observers are not allowed to take any pictures or record videos or audio while participating as an observer. #8) As an observer, you must be in civilian clothing appropriate to the occasion (e.g., open toed shoes, shorts, tank tops, ripped jeans, or other revealing attire is not appropriate and will not be permitted for a ride-along), #9) Health and wellness hold high importance to our staff and community. All observers/riders must be free of any illnesses or symptoms of illnesses. Please do not show up for a ride along if you have any flu like symptoms. 10) The personal safety of the crew and the Fire District's responsibilities to the community will be considered at all times. Therefore, a request may be denied in advance for any reason, or a Company Officer may terminate your ride-along at any time, without explanation or advance notice. I have not offered any payment to the Fire Department or any of its employees for the opportunity to ride in a vehicle. WHEREFORE, in consideration of the educational benefit to be received by me with the granting of this request, I hereby agree to hold the Nampa Fire Protection District, its commissioners, and its Chief, employees, agents, and servants harmless from any and all liability to me for death, personal injury, or property damage, whether proximate or remote, sustained during the period of time I may be in the capacity of an observer, as aforesaid.
