### **AGREEMENT TO TERMS**

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and [business entity name] ("we," "us" or "our"), concerning your access to and use of the [website name.com] website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Ethos app").

Supplemental terms and conditions or documents that may be posted on the Ethos app from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms and Conditions at any time and for any reason.

We will alert you about any changes by updating the "Last updated" date of these Terms and Conditions, and you waive any right to receive specific notice of each such change.

It is your responsibility to periodically review these Terms and Conditions to stay informed of updates. You will be subject to, and will be deemed to have been made

aware of and to have accepted, the changes in any revised Terms and Conditions by your continued use of the Ethos app after the date such revised Terms and Conditions are posted.

The information provided on the Ethos app is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject us to any registration requirement within such jurisdiction or country.

Accordingly, those persons who choose to access the Ethos app from other locations do so on their own initiative and are solely responsible for compliance with local laws, if and to the extent local laws are applicable.

These terms and conditions were created using Termly.

Except as expressly provided in these Terms and Conditions, no part of the Ethos app and no Content or Marks may be copied, reproduced, aggregated, republished, uploaded, posted, publicly displayed, encoded, translated, transmitted, distributed, sold, licensed, or otherwise exploited for any commercial purpose whatsoever, without our express prior written permission.

Provided that you are eligible to use the Ethos app, you are granted a limited license to access and use the Ethos app and to download or print a copy of any portion of the Content to which you have properly gained access solely for your personal, non-commercial use. We reserve all rights not expressly granted to you in and to the Ethos app, the Content and the Marks.

## **USER REPRESENTATIONS**

By using the Ethos app, you represent and warrant that:

- (3) you have the legal capacity and you agree to comply with these Terms and Conditions;
- [(4) you are not under the age of 13;]

- (6) you will not access the Ethos app through automated or non-human means, whether through a bot, script, or otherwise;

You are solely responsible for your Contributions to the Ethos app and you expressly agree to exonerate us from any and all responsibility and to refrain from any legal action against us regarding your Contributions.

We have the right, in our sole and absolute discretion, (1) to edit, redact, or otherwise change any Contributions; (2) to re-categorize any Contributions to place them in more appropriate locations on the Ethos app; and (3) to pre-screen or delete any Contributions at any time and for any reason, without notice.
