Sealed quotations/tenders are hereby invited from interested persons / Registered Firms / Travel Agencies / Trusts having valid GST Registration Certificates for providing a commercial light vehicle having sitting capacity not more than 08 including driver i.e. (preferably BOLERO or any SUV of equal category) bearing commercial registration number, along with a driver, for deployment under NAC, Purushottampur for official use on a monthly rental basis, as per the terms and conditions detailed below:

#### **Eligibility & Conditions**

- The service provider must have a valid GST Registration Certificate to participate in the tendering process.
- 2. The vehicle must:
  - o Be in roadworthy condition,
  - Not be more than 3 years old from the date of initial registration till the date of bid submission, and
  - Have valid documents including Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, Contract Carriage Permit, and proof of up-to-date tax payment, as required under law.
- 3. The driver of the vehicle must:
  - o Possess a valid **Driving License** for light transport passenger vehicles,
  - o Have sufficient driving experience, and
  - o Be well-behaved, gentle, and obedient in nature.
- 4. Earnest Money Deposit (EMD):

A sum of **Rs. 5000**/- (Rupees Five Thousand only) shall be deposited by the intending bidders in the form of an **Account Payee Bank Draft** drawn in favour of the **Executive Officer**, **NAC**, **Purushottampur**, payable at Purushottampur, and submitted along with the tender. After completion of the tender process, the EMD shall be refunded to unsuccessful bidders.

- 5. The monthly hire charges (excluding GST and fuel) shall be quoted separately.
- 6. The vehicle must achieve a minimum fuel efficiency of 10 KM per litre.
- 7. In case of equal bid amounts, supplier shall be selected through lottery process.
- 8. The bidder shall agree to the terms and conditions at Annexure-A

#### Annexure-A

#### **Terms & Conditions**

- 1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as valid Registration Certificate, Insurance Certificate, Pollution Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc. and D.L. of the driver available all the times.
- 2. The Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
- 3. The hire charges to be paid for monthly basis is final but does not include cost of fuel, which is to be paid separately as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
- 4. It shall be the responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by the service provider.
- 5. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the service provider.
- 6. In case of the vehicle do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.
- 7. The vehicles shall report for duty during emergency hours in addition to regular duty.
- 8. In case of emergency, the driver will have to report for duty as per the requirement. No extra payment shall be made.
- 9. Monthly hire charges will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
- 10. The vehicle shall not be more than 3 years old from the initial registration to the date of notification of this bid and also in good running condition during the period of contract.
- 11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
- 12. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
- 13. If the bidder violates any of the terms of contract, ULB shall forfeit the entire amount of security deposit.
