Welcome to the 2025-26 track and field season! The Starting Line central hub within RQ+ provides a platform where we can continue to educate, inform, and update NCAA track and field officials as we strive to grow and improve the sport of track and field.

Now that you have registered on RQ+, you will need to complete the track and field resume form. You can access the form by clicking "Forms" from the menu bar at the top and then choose "2025-26 Track and Field Resume" and click "Submit New Response." When completing the resume form, please note the following:

- Please be sure to complete all resume sections.
- Select your area by preference. You should only be selecting areas in which you are skilled, and which are supported by your resume. You should be selecting areas in which you are certified at a national level or higher with experience at Division I, Division II and/or Division III championship level meets such as NCAA's or conference championships. You should NOT be selecting areas for consideration in which you have no championship experience.
- You will not be selected for an officiating duty you did not choose.
- Select the championship event(s)/site(s) you are available and willing to officiate, by preference (This will be taken into consideration when selections are made.). Note the following dates and locations for this year's championships:
 - o March 13-14, 2026: Division I Indoor Track and Field Championships (Fayetteville, AR)
 - o March 13-14, 2026: Division II Indoor Track and Field Championships (Virginia Beach, VA)
 - o March 13-14, 2026: Division III Indoor Track and Field Championships (Birmingham, AL)
 - o May 21-23, 2026: Division II Outdoor Track and Field Championships (Emporia, KS)
 - o May 21-23, 2026: Division III Outdoor Track and Field Championships (La Crosse, WI)
 - o May 27-30, 2026: Division I Outdoor Track and Field East First Rounds (Lexington, KY)
 - o May 27-30, 2026: Division I Outdoor Track and Field West First Rounds (Fayetteville, AR)
 - o June 10-13, 2026: Division I Outdoor Track and Field Championships (Eugene, OR)
- You will not be selected for a championship event/site you did not choose.
- If you encounter issues, please utilize the RQ+ support team which can be accessed by emailing support@refquest.com or clicking the "? Support" button in the lower left-hand corner when logged in on the RQ+ website.

The deadline to complete the resume form and all necessary eligibility requirements for selection consideration for 2026 NCAA track and field championship events is **September 15**, **2025**. Final selections for the eight Division I, Division II and Division III indoor and outdoor track and field championship events will be announced in mid to late December.



Please visit the Starting Line central hub frequently to stay current on the latest NCAA track and field officiating news and information. On the central hub, you'll be able to read the latest rules interpretations from the secretary-rules editor and bulletins from the national officials' assignor, complete your additional requirements (e.g., viewing of SportRadar video) to be considered for NCAA championship assignments, and view other educational information.

Please also note that if selected to work one or more of the NCAA track and field championship events, that you will be required to consent to a background check and sign an agreement prior to working any of the championships.
