**ORDER:**

In the representation 4<sup>th</sup> read above, the President/General Secretary, A.P.P.T.D. Employees Union has stated that APSRTC Employees Union has been formed in the year 1952 and for the last 71 years, it is striving hard for the betterment of lives of RTC Employees and it represents the work force from the rank of Shramik to Asst. Manger i.e. lower level to Supervisor level consisting of 20510 number of employees out of 50000 employees in AP PTD and it is having 39.83% membership and it has been instrumental in taking up the causes of the RTC Employees. After absorption of the APSRTC into Government by name AP Public Transport Department and merging of all the APSRTC Employees into Government Service w.e.f. 01.01.2020, the erstwhile APSRTC Employees' Union has been formed in the name of A.P.P.T.D. Employees Union and got registered on 10.11 2020 with bearing No.155/2020 under Societies Registration Act 2001. The President/General Secretary, A.P.P.T.D. Employees Union have requested to accord recognition to their association under A.P.C.S.ROSA Rules, 2001.

2. In the letter 5<sup>th</sup> read above, the Commissioner, PTD Ex-Officio VC&MD, A.P. has stated that 106 categories of employees working in various wings in different categories such as Operations, Mechanical Engineering, Civil Engineering, Personnel, Finance and Medical etc. out of the total cadre strength of 51,488 in the A.P. Public Transport Department. Therefore, it is practically not possible to form category wise Service Association exclusively to each category. The A.P. P.T.D Employees Union, in its earlier form as APSRTC Employees Union, with the amalgamation of different categories of employees, has been in existence for the last 71 years i.e., from a date much prior to the absorption of APSRTC employees into Government service on 01.01.2020 and in the post absorption scenario, continued duly registering under Societies Registration Act 2001 with its name as " A.P. P.T.D. Employees Union" in Public Transport Department in order to fall in line with the requirements of Government rules. A.P.P.T.D Employees Union is having strong presence in APSRTC/APPTD as a

representative Union of employees of various categories, and playing a significant role on behalf of various categories of APPTD in getting the grievances resolved. In the circumstances stated above, the Commissioner, PTD Ex-Officio VC&MD, A.P. has recommended the request of the President/General Secretary, A.P.P.T.D. Employees Union to grant recognition.

3. After careful examination of the matter, Government hereby accord recognition to the "A.P.P.T.D Employees Union (Regd.No.155/2020) in relaxation of Rule 3 (1) (a) of the APCS (ROSA) Rules, 2001 by exercising the powers conferred by Rule 5 of the ROSA Rules issued in the reference 1<sup>st</sup> read above, as a special case for the purpose of enabling its members to make representations regarding their conditions of service and matters pertaining thereto for redressal.

4. A.P.P.T.D Employees Union shall follow and adhere strictly to the A.P.Civil Services (ROSA) Rules, 2001, issued in the G.O. 1<sup>st</sup> read above and other orders issued by the Government from time to time and shall furnish any change in its Rules, Bye-laws which are in accordance with A.P. Civil Services (ROSA) Rules, 2001 and also any changes that may be made in its name, address or headquarters etc., to the Government and take approval by the Government to that effect.


