Sub: ESTABLISHMENT – Method of filling the post of DM by the JSOs of OPD, MED, PD, AD, SPD and CED – Specifying the roster points in the 50 point administrative roster for OPD, MED, PD, AD, SPD and CED – Notification – Issued.

As per the Notification under reference 1st cited, the ratio for filling the posts of Depot Manager by the transfer of JSOs of various departments was fixed as 27:15:1:2:4:1 among OPD, MED, PD, AD, SPD and CED respectively.

In terms of the provision in the APSRTC Employees' (Recruitment) Regulations, the Corporation Board reviewed and resolved vide Resolution 2nd cited to revise the ratio besides making partial amendment in the method of filling the posts of Depot Manager as furnished hereunder.

1. The existing ratio among OPD, MED, PD, AD, SPD and CED is modified from 27:15:1:2:4:1 to that of 23:19:2:2:2:2 respectively in a cycle of 50 administrative roster points for filling the vacancies of DM posts by promotion from the front-line supervisors.
2. If frontline supervisors of functional departments of PD, AD, SPD and CED do not avail the opportunity given to work as DMs on promotion, such administrative roster points shall get lapsed.
3. The front line supervisors of functional departments of PD, AD, SPD and CED availing the promotional opportunity on willingness to work as DMs, shall invariably work for a minimum tenure of three years as DM. Lest they will forego the promotion and be reverted to former post in supervisory cadre of respective functional departments.
4. To adopt the revised administrative roster of 50 points of DMs prospectively from the date of board resolution.

The revised Roster for filling the posts of Depot Manager in a Unit of 50 is shown at Annexure to this Notification.
