



Expression of Interest for Empanelment of Training Providers/Centers to impart skill training within industry to fresh recruits

Leather Sector Skill Council (LSSC), a sector Skill Council for Leather and Footwear invites proposals from Training Providers/Centers for empanelment with LSSC for providing domain skilling and wage employment supported by Central and State Skill Missions.

The basic objective of this EOI is for selection of reputed organizations / industry pioneers /institutions as **"Training Partner"** to set up Short Term Skill Training for imparting skills to unemployed youth to cater to the specific job requirements of Leather and its allied industry under the national mission of Skill India. The Organizations/Industry Associations can directly partner with LSSC and can build a skilled workforce as per their domain requirement for meeting their needs.

<u>Eligibility Criteria</u>: The Training Providers complying following criteria may submit their proposal at <u>Issc@leatherssc.org</u> maximum by <u>14th August, 2024</u> in the prescribed format (Annexure – I) on the company letterhead with the interest to getting empanelment with LSSC for skill training and employment. There is no fee for Training Providers to submit their Expression of Interest (EoI).

- > The Organization should be operational for past 3 years.
- Average revenue of the skill training activities should be a minimum of Rs. 70
 Lakh annually.
- > The training centers should have well-equipped classrooms.
- > The company should have a valid PAN, and GST.
- > Bidder entity should have a positive net-worth as on 31st March 2024.
- Company registered under the Companies Act or Trust registered under Public Trusts Act, 1950.
- > Average Turnover of the Institute/Company/Trust must be minimum INR 2.0 Crores





for financial year 2020-21 to 2022-23.

- Skill Development should be included under Memorandum of Article / bye laws as Objects under Trust / Incorporation of Company.
- > The company/ entity should be registered on or before 1st April 2020.
- Shall be accredited to National Skill Development Council (NSDC) or State Skill Development Mission (SSDM), Sector Skill Council, DDUGKY as a Funded/Non-Funded Partner.
- > The training infrastructure shall be as per the NSDC / Leather SSC norms.
- Company/Trust shall have registered office or regional office in State where State projects are involved with active operations for at least 3 years
- Should have trained at least 1000 candidates in various skill development programs since 2020-21.
- > Must have placement rate at least 75% in various industries as mentioned.
- Two or more entities that have a common proprietor or a common director in the Board of Directors are not allowed to submit separate EOI document for the same location.
- Upon selection, of the Training Partner should pay the prescribed fee and adhere to the guidelines specified in the Annexure – II.
