RT KIDNEY: - Is normal in size regular in shape and position. Bipolar length -9.7cm. The cortical echogenicity are normal with clear cortico-medullary differentiation. The cortical thicknesses are normal. The renal sinus shows normal echogenicity and thickness.

URETER: There is no dilatation in both ureter.
