Avoid lines at your county tax office. Mail in payment or pay online. Additional charges will apply to the provider. Credit/Debit card payments can be processed by phone at 1-803-797-2853 or online at https://lancastersctax.qpaybill.com

The owner of personal property that is required to be licensed or registered with an agency or department of the state may appeal in writing to the county auditor the valuation of the property at any time on or before the last day the tax levied upon the assessment can be timely paid. All business personal property returns, address changes and appeals must be submitted to S.C. Department of Revenue. Please contact them at 803-898-5222.

Tax bills for real property are issued to the owner of record as of December 31, 2023. If you have transferred ownership of this property, the new owner may currently be liable for this charge, depending on the agreements that were made between the buyer and seller at the time of sale. Lancaster County does not prorate or divide taxes on real property. This charge becomes a lien on the property until the payment is made.

The original tax notices are mailed to the taxpayer. If your taxes are paid by a Mortgage Company, please check with your Mortgage Company for payment.
