

Terms of Agreement continued

12. The district is not responsible for lost or stolen items.
13. All students using the facility outside of school activities must have a membership. Students are not entitled to facility usage just because they are a student. (Just because a student is out for basketball does not entitle them to use the facilities outside of practice or games without a membership.)
14. Shirts and shoe must be worn during occupancy. No black soled shoe or shoes that mark the floor will be permitted.
15. Water bottles will be permitted, but no food, gum or beverages are allowed in the gym
16. Dunking, slamming or hanging on the rims or nets will not be allowed.

Due to security and liability concerns, before access is set up, all current and new members must complete our Jaguar Den Fitness Den Membership Survey. Survey link will be sent via email to each person to the email address given on your membership application.

Survey must be completed by each person that holds a credential (key) to gain access to the high school facilities to ensure that everyone is following the same expectations.

Anyone that disregards the expectations may have their membership revoked briefly, permanently, and/or face criminal charges. *The District reserves the right to suspend a membership without notice*

Entry door system uses HID Mobile Access App for access to the facilities. Members will need to supply their email address to receive the mobile app information to setup their access.

Once membership is paid for and survey is submitted, each person that is eligible for the mobile access, will receive an email invitation with the subject line "Your HID Mobile Access Invitation code" which will include the link to install the HID App and instructions for accepting the invitation code..

Students in high school will need to supply an email address to be set up for access also when they purchase a student membership.

- ◆ The competition gym, hallways, and classrooms are not accessible to members.
- ◆ Priority will be given to School District events and Indoor Sports Community Youth Athletic Organizations.

Terms of Agreement

1. This membership is for only the member that holds the credential on their phone. The member will not let anyone else into the facility. (Short-term guest passes are available by contacting the district office.)
2. The district is tracking facility use by digital entry credentials and cameras.
3. Allowing others into the facility that do not have a membership may result in temporary or permanent membership revocation, including criminal charges. (If an individual is part of a family membership, the entire family membership will be revoked, not just the guilty individual.) It was asked, how will I know if someone is or isn't a member? Easy, always make the individual use their phone to access the facility. Do not open the doors for anyone.
4. Any family member, 8th grade or younger, must be accompanied by a parent. A sibling may not supervise a younger brother or sister. Another community member may not supervise a non-family member or a group of kids. A parent/guardian must be present.
5. Members will not give others their phones to gain access. This may result in temporary or permanent membership revocation, including criminal charges. (If an individual is part of a family membership, the entire family membership will be revoked, not just the guilty individual.)
6. Members may gain access after 6PM on school nights and any time after 5:30AM on days that school is not in session. The facilities will close at 10:30PM.
7. Weight room and gym facilities should be left as they were found or better. If anything is in disarray, please note the time and notify the District Office. There are many cameras and we will find out who is not meeting expectations.
8. Respectful music only. Any music with cursing or potentially racist, sexist, or homophobic lyrics will not be tolerated and result in membership revocation, temporary or permanent.
9. Doors may NEVER be propped open. (There are alarms on the door and the district will be notified.)
10. Tobacco, vapes, alcohol or illegal drugs are prohibited as is being on the premises under the influence of drugs or alcohol.
11. With many facility members, all facilities must be shared. Games/practices not affiliated with school will be tolerated only until others want to use the facility. (High School groups that arrange to use the facility ahead of time will be given priority.)
