# Syncs.bio Privacy and Cookie Policy Last updated: November 2023

## **Welcome to Syncs.bio**

We are committed to respecting your privacy and protecting your personal data. This Syncs.bio Privacy and Cookie Policy ("Policy") sets out how we use data relating to you and applies to all use of your personal data by Syncs App Ltd. a private company incorporated and registered in England and Wales with company number 15902605 whose registered office is at 483 Green Lanes, London, N13 4BS ("we", "us" or "our ").

This Policy sets out the basis on which any personal data we collect from you, or that you provide to us through our mobile/tablet applications or our website (<a href="https://syncs.bio/">https://syncs.bio/</a>) (together, "Syncs.bio") will be processed by us. This Policy applies to all users of Syncs.bio, including individuals and businesses who use Syncs.bio to create and manage their content, products, events, tickets, experiences, subscriptions, and other offerings ("Services"), and their customers or users who engage with the Services ("End Users"). Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

We will only collect and process information about you in accordance with this Policy and will only use information collected about you in accordance with applicable data protection laws, including the EU General Data Protection Regulation 2016 ("EU GDPR"), the EU GDPR as it forms part of the laws of England, Wales, Scotland, and Northern Ireland by virtue of section 3 of the European Union (Withdrawal) Act 2018 ("UK GDPR," and together with the EU GDPR, the "GDPR"), and the UK Data Protection Act 2018.

You have the right to object to the processing of your personal data, including where your personal data is being processed for direct marketing purposes. Further information on this right, and your other rights, is set out below.

#### 1. WHAT IS OUR ROLE WHEN PROCESSING PERSONAL DATA?

- 1.1 Where we decide the purposes and means for the processing of your personal data, we are the "controller" for the purposes of the GDPR. This means we are generally a controller for the following:
- 1.1.1 Processing of personal data in connection with the operation, hosting, and management of your Syncs.bio account and the provision of Syncs.bio's services to you; and
- 1.1.2 Processing the personal data of individuals who contact us via our support email address, sign up for the Syncs.bio waiting list or Syncs.bio newsletter/marketing/update communications, or use the Syncs.bio website (https://syncs.bio/).
- 1.2 If you are using our platform to manage your own content or services, there may be instances where you decide the purposes and means for the processing of personal data, and we simply process that personal data according to your instructions and on your behalf. In such circumstances, you are the "controller" and

we are the "processor." This means we are generally a processor for the processing of personal data through your individual Syncs.bio profile page, for example, when your customers sign up to a newsletter, click on links to purchase merchandise, or interact with you on your profile page.

- 1.3 This Policy addresses the processing of personal data that we undertake as a controller. Please refer to the privacy policies available from within any profile page for further details of the processing of your personal data by the profile owner as a controller.
- 1.4 While users are contractually obligated to comply with all applicable data protection laws, we do not accept any responsibility or liability regarding how users handle personal data.

# 2. HOW WE COLLECT AND USE YOUR PERSONAL DATA

2.1 The table below explains what data we may collect, how we use it, and which recipients it might be shared with.

# Methods of Data Collection:

We collect data through the Instagram API after the user connects their account and provides consent. We only store the long-term access token, which is used to retrieve information on recent posts.

Legal Basis for Data Processing:

We process the data based on the user's consent, given when they log in through Instagram.

Security Measures:

We apply encryption to protect user data and conduct regular security checks to prevent unauthorized access.

# 3. YOUR RIGHTS IN RELATION TO YOUR PERSONAL DATA

- 3.1 You have the following rights in respect of your personal data:
  - Ask us for a copy of personal data we are processing about you.
  - Ask us to correct inaccuracies in your personal data.
  - Ask us to restrict, stop processing, or to delete your personal data.
  - Ask us for a machine-readable copy of your personal data, which you can use
    with another service provider. Where it is technically feasible, you can ask us
    to send this information directly to another provider if you prefer.
  - Object to our processing of your personal data.
  - Object to the use of your personal data for direct marketing.
  - (Where we rely on your consent to process your personal data) withdraw your consent at any time.
  - Make a complaint to a data protection regulator. You may contact the UK regulator at: <a href="https://ico.org.uk/concerns/">https://ico.org.uk/concerns/</a>.
- 3.2 To make a request in relation to any of the aforementioned rights, please send your request to us through our dedicated customer services team at: support@syncs.bio. We aim to comply without undue delay, and within one month at the latest, in response to any requests submitted by you to us in connection with your rights.

## 4. DISCLOSURE OF YOUR PERSONAL DATA

4.1 Other than as set out under 'Recipients' above, we may disclose your personal data to:

- 4.1.1 **Our group, subcontractors, and application stores.** We keep your personal data confidential, but may disclose it to any member of our corporate group, our personnel, or subcontractors insofar as it is reasonably necessary for the purposes set out in this Policy, and on the legal basis of meeting our obligations under our contract with you, or our legitimate interests in outsourcing certain functionality to subcontractors or corporate group members.
- 4.1.2 **Government authorities.** In addition, we may disclose your personal data to the extent that we are required to do so by law (which may include to government bodies and law enforcement agencies); in connection with any legal proceedings or prospective legal proceedings; and to establish, exercise, or defend our legal rights (including providing information to others for the purposes of fraud prevention). In each case, we do so on the basis of our legal obligations.
- 4.1.3 **Potential acquirers or investors.** If we are involved in a merger, acquisition, or sale of all or a portion of our business or assets, personal data we hold may be shared based on the legitimate interests of us, our shareholders, customers, and other parties to a transaction, unless those interests are outweighed by prejudicial impacts upon you.
- 4.1.4 **Enforcement.** We may also disclose your personal information to third parties in order to enforce or apply the terms of agreements, to investigate potential breaches, or to protect the rights, property, or safety of us, our personnel, customers, or others. We do this on the legal basis of our legitimate interests in ensuring our services are used lawfully and in accordance with our policies, and in ensuring the rights of others are not negatively impacted by anyone's use of our services.
- 4.1.5 **Suppliers and service providers.** We may use a range of suppliers and service providers to operate our business.
- **4.2** In addition to the above, Syncs.bio may contain links to third-party functionality, apps, or websites (such as, for example, the YouTube video player). These third-party functions, apps, or websites may have their own privacy policies, and we recommend that you review them. We do not accept any responsibility or liability for the privacy practices of such third parties, and your use of their services is at your own risk.

## 5. DATA RETENTION

- **5.1** We will only hold data about you for as long as necessary, bearing in mind the purpose for which that data was collected, or as otherwise described in this Policy.
- **5.2** To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorized use or disclosure of your personal data, the purposes for which we process your personal data, and whether we can achieve those purposes through other means, as well as the applicable legal requirements.

#### 6. SECURITY

- **6.1** We will take commercially reasonable, appropriate technical and organizational measures to ensure a level of security appropriate to the risk that could be encountered via the use of Syncs.bio, taking into account the likelihood and severity of those risks that might pose to the rights and freedoms of Syncs.bio users.
- **6.2** In particular, we will take precautions to protect against the accidental or unlawful destruction, loss, or alteration, and unauthorized disclosure of or access to the personal data transmitted, stored, or otherwise processed by us.

## 7. INTERNATIONAL DATA TRANSFERS

- **7.1** We are primarily based in the United Kingdom and use servers and service providers located in multiple jurisdictions.
- **7.2** Where we use service providers located outside the United Kingdom, there are agreements in place to ensure that personal data is processed using appropriate safeguards that meet the requirements of data protection laws. Such appropriate safeguards may include standard data protection clauses adopted by a data protection regulator and approved by the UK Data Protection Regulator and/or European Commission, such as the European Commission's standard contractual clauses.
