Catholic Relief Services [CRS] South Sudan program invites sealed bids from eligible applicants to tender for transporting USAID Title II food commodities and non-food items [NFIs] in Jonglei State, South Sudan. The vendors are required to quote for the three [3] types as follow:

1. Dry season 4x4 and large capacity: 20MT;30MT and 40-45MT
2. Wet season long distance 6x6 and 8x8 and small capacity: 10MT and 15 MT
3. Wet season short distance 4x4 and small capacity: 7MT and 10MT The commodities are funded by USAID/Food for Peace [FFP],
