- 1. The Government of Kenya has received financing from The World Bank toward the cost of the Coastal Region Water Security and Climate Resilience Project and intends to apply part of the proceeds from this financing for payment of Consulting Services for Kwale County Improved Sanitation Communications Campaign.
- 2. The Consultancy assignment is a multi-pronged advocacy for subsidy-free household intervention on two main areas of sanitation and hygiene.
- 3. In terms of scope of the assignment, this sanitation campaign will be implemented over twelve months covering the entire Kwale County. Roll-out will happen in phases, such that early experience may be used to revise and expand the campaign across the sub counties and wards. Subject to performance and monthly reviews, this contract may be extended for broader roll-out of the campaign.

- 6. The Ministry of Water and Sanitation now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short-listing criteria are related to applicants' competence and qualifications, as follows:
 - a) The relevance and suitability of the applicant's core business to the Terms of Reference for the assignment and the applicant's capability and strength as demonstrated through its institutional, technical, financial, managerial competence and its quality management systems;

- b) Applicant's demonstrated experience in sanitation hygiene behavior change communication
- c) Demonstrated experience in formative research in communication options
- d) Demonstrated experience in executing multimedia promotional campaigns.
- e) Demonstrated experience in working with rural populations.
- f) Demonstrated record in placing media activities for large-scale campaigns through local mass media.

Availability of staff conversant with communicating in Kiswahili, Mijikenda and other local languages will be an added advantage.
