SEEKING EXPRESSION OF INTEREST (EOI) CONSTRUCTION SERVICES

The Feed the Future Kenya Livestock Market Systems Activity aims at strengthening people's resilience to shocks and stresses, and to reduce the prevalence and depth of poverty, household hunger, and chronic under nutrition. This is done by taking collective action in expanding economic opportunities, and by strengthening institutions, market systems, governance, and human capital.

Feed the Future Kenya Livestock Market Systems Activity invites interested local contractors operating in Isiolo, Garissa, Marsabit, Turkana, and Wajir counties with experience in construction, to express interest to be pre-qualified to bid for construction activities in the five counties. The opportunities will include construction of commercial business facilities and/or community infrastructure.

To pre-qualify, interested contractors will be required to have:

- a) Certificate of Incorporation
- b) Current Registration Certificate and practicing licenses with National Construction Authority
- c) Valid Tax Compliance Certificate, PIN and VAT certificates from Kenya Revenue Authority
- d) A detailed list of all construction activities including value of construction work performed for each of the last three years
- e) Evidence of completed prior works of a similar nature within the counties of Isiolo, Marsabit, Turkana, Wajir, and Garissa
- f) List of construction equipment proposed to carry out these activities either owned or hired
- g) Pre-qualification questionnaire as per Appendix A [to be submitted in soft copy].
- h) Comprehensive company profile.
- i) CVs of relevant staff and their daily labor rate to be pre-qualified for work
- j) Audited accounts

- b) Please note that this is a new pre-qualification and contractors that were previously pre-qualified under the Resilience and Economic Growth in the Arid Lands - Accelerated Growth [REGAL-AG] will be required to resubmit pre-qualification documents for consideration under Feed the Future Kenya Livestock Market System Activity.
- c) This is not an invitation to tender. Full tendering procedures will be applied to contractors prequalified and found capable of executing the projects.
- d) Only successful contractors will be contacted for tender processes as and when they fall due.
