#### CONSTRUCTION OF UGUNJA-SEGA-UKWALA WATER SUPPLY AND SANITATION PROJECT

1. This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in UN Development Business Online on 31<sup>st</sup> March 2017.
2. The Government of Kenya has received financing from the African Development Bank in various currencies towards financing the Kenya Towns Sustainable Water Supply and Sanitation Program. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for "Construction of Ugunja-Sega-Ukwala Water Supply and Sanitation Project".
3. Rift Valley Water Services Board (RVWSB) on behalf of Lake Victoria South Water Services Board (LVSWS8) now invites sealed bids from eligible bidders for execution of the above project
4. The scope of works includes but not limited to the following under one contract:
  - a) Construction of intake works and 380m long lined canal to turbine and treatment plant
  - b) Construction of approx. 100m OD 1500mm steel headrace pipeline to turbine pump house
  - c) Construction of 8,400m<sup>3</sup>/day conventional water treatment plant including 1500m<sup>3</sup> RC contact tank, 500m<sup>3</sup> elevated steel back wash tank, treated water pump station and associated buildings
  - d) Power supply and electromechanical works at the Treatment Plant consisting of 3No. set of treated water electrical and hydroturbine pumps, 2No. back -wash voter pumps. 2 No. air blowers, surge tank etc. including associated control panels and electricals
  - e) Construction of 11.6 km, DN 400 Steel treated water rising main
  - f) Construction of 6.7 km DN 400 Steel and 20.1km OD200 - 355mm HDPE transmission mains
  - g) Construction of 1 no 1,500m<sup>3</sup> RC tank. 4No. 500m<sup>3</sup> and 2No. 300m<sup>3</sup> steel elevated tanks
  - h) Construction of approximately 61.5km. 24.7km and 44.4km 009O-355mm HDPE distribution pipelines in Ugunja, Segwa and Ukwala respectively

- i) Supply and delivery of 40km OD25-63mm HDPE reticulation pipes, 3000No. consumer meters with fittings for last mile connectivity and operational tools
- j) Construction of 10 No. Public Water Kiosks and 6No. ablution blocks

5. 6. A Complete set of bidding documents in soft copy (CD) may be purchased by interested bidders on the submission of a written application to the above and upon payment of a non-refundable fee of Kshs 1,000.00 (Kenya Shillings One Thousand Only).

7. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of Works.

8. Bidders are invited for a Pre-bid meeting to be held at LVWSB offices at Lavictors House in Kisumu on 18<sup>th</sup> September 2018 starting at 10.00am East African time) for any clarifications before bidding. Afterwards, site visits shall be organized to the proposed sites in Ugunja, Segwa and Ukwala Towns on the same day at 12.00pm (East African time).

9. Bids must be delivered to the above office on or before 12.00pm (East African time) **on 18<sup>th</sup> October, 2018** and must be accompanied by a bid security of Kshs 5,000,000.00 (Kenya Shillings Five Million Only) or equivalent amount in a freely convertible currency and with a bid validity period of 120 days from bid submission date.
