The Ministry of Health with support from the Global Fund plans to train Six Thousand (6000) public sector health workers countrywide. The goal is to capacity build health workers on Malaria Case Management and to strengthen diagnosis based policy on malaria treatment.

The training will cover all the counties in Kenya and is based on an integrated malaria training curriculum, which focuses on the current and updated policy guidelines for the diagnosis, treatment and prevention of malaria.

The Ministry of Health therefore invites proposals for the following consultancy services;

Scope of work

The consulting firm is expected to work closely with the Ministry of Health through the National Malaria Control Program (NMCP), and the County Health Management Teams (CHMTs) to accomplish the following tasks

- a) Source for trainers (TOTs) who will be trained by NMCP on the integrated training package;
- b) Plan and conduct a three (3) day, training for public facility health workers based on the integrated training curriculum for malaria.
- c) Provide to NMCP training reports in the prescribed format;
- d) Provide a list of all public health workers trained as per the prescribed format.

Minimum requirements

- 1) Certificate of Registration / Incorporation and CR12
- 2) PIN Certificate
- 3) Submit a dully filled original tender document and a copy in the required format
- 4) Bank/insurance guarantee worth Kshs. 200,000.00 (Two hundred thousand) per bid
