REQUEST FOR EXPRESSION OF INTEREST FOR CONSULTANCY SERVICES FOR THE DIGITAL TOPOGRAPHICAL MAPPING AND PREPARATION OF INTEGRATED STRATEGIC URBAN DEVELOPMENT PLAN FOR HOLA MUNICIPALITY IN TANA RIVER COUNTY:

CONTRACT No. TRCG/HOLA/PPD/ISUD-01/2018/19

The County Government of Tana River intends to outsource Consultancy Services for Digital Topographical Mapping and Preparation of Integrated Strategic Urban Development Plan (ISUDPs) including a Plan and Capital Investment Plan (CIP) for Hola Municipality.

The objective of the Consultancy is to prepare an ISUDP for HOLA Municipality in line with the County Government Act of 2012, the Urban Areas and Cities Act of 2011, and the existing Physical Planning Act of 1996 rev. 2012. And the Public Procurement and Disposal act of 2015. Tasks for each include;

- i. Compile digital topographical maps and update existing base maps,
- ii. Conduct participatory planning exercise in the towns as a key input for preparation of the digitalized plans,
- iii. Produce a physical structure plan, showing current and proposed infrastructure (e.g. transport, water, drainage, power, etc., environmental assets, land use, densities, building form, design standards and heights), and
- iv. Based on local priorities and proposed structure plan prepare a financially feasible three year Capital Investment Plan, taking into account budget constraints.

A consultant will be recruited to conduct this assignment in Hola Municipality and the towns within the boundaries of the Municipality. This will include a well detailed plan of Hola Town which is the major urban and market centre within the Municipal Boundary. As per the above deliverables, this will include reviewing of the existing Urban Plan and related land and resource information for Hola Town with a view to preparing a Capital Investment Plan (CIP) for funding.

The assignment is expected to take a total of approximately six (6) calendar months. This means that multiple teams may be deployed simultaneously in several towns.
