Mandatory requirements

1. Certified Copy of Certificate of registration/incorporation.
2. Certified Copy of valid tax compliance certificate/exemption certificate issued by KRA
3. Certified Copy of CR 12 certificate
4. Registration with the National Construction Authority for Building works; MUST be accompanied by a valid Annual practicing license
5. Certified KRA Pin certificate issued by KRA
6. Bid bond amount as indicated in the advert and tender documents
7. Duly filled, signed and stamped Tender form
8. Duly filled, stamped and signed Business Questionnaire Form
9. Certified Single Business Permit from relevant County Government
10. MUST provide Copies of the national ID/passport for the directors as per CR12
11. All pages MUST be serialized/paged

Further, Tenders from the following Tenderers shall be treated as Non-Responsive and therefore subject to disqualification:
