1.0 INVITATION TO TENDER

2.0 - INSTRUCTIONS TO TENDERERS

2.1 Eligible Tenderers

This Invitation for Tenders is open to all individuals, sole proprietors, partners, companies and organisations.

2.2 Cost of Tendering

The tenderer shall bear all costs associated with the preparation and submission of its tender. The price to be changed for the tender document shall be Kshs.5,000/=

2.3 The Tender Document

The tenderer shall be expected to fill in the following forms:

- (i) Form of tender
- (ii) Confidential Business questionnaire Form

2.4 Amendment of Documents

At any time prior to the deadline for submission of tenders, the Seller, for any reasons, whether at its own initiative or in response to a clarification requested by a prospective tenderer, may modify the tender documents by issuing an addendum. All prospective candidates that have purchased the tender documents will be issued with the addendum in writing or by post and will be binding on them.

In order to allow prospective tenderers reasonable time in which to take the addendum into account in preparing their tenders, the Procuring entity, at its discretion, may extend the deadline for the submission of tenders.

2.5 Tender Prices and Currencies

The tenderer shall indicate on the appropriate Price Schedule the unit prices and total tender price of the land parcel(s) it proposes to purchase under the contract. Prices quoted by the tenderer shall be fixed during the tender validity period and not subject to variation on any account. The Price quoted shall be in Kenya Shillings.

2.6 Validity of Tenders

Tenders shall remain valid for 180 days after date of tender opening. Tender valid for a shorter period shall be rejected by the Procuring entity as non-



responsive. The seller may solicit the Tenderer's consent to an extension of the period of validity and the tenderer granting the request will not be required nor permitted to modify its tender.

2.7 Viewing of Tender parcels of Land

Prospective bidders are advised to view the parcel(s) of land in liaison with Tysons Limited before they bid. This will enable them to arrive at the most reasonable and competitive bids. The conditions of the parcel(s) of land and the improvements thereon are not warranted by the seller.

2.8 Sealing and Marking of Tenders

The tenderer shall seal the tender and mark it with the number and name of the tender and "DO NOT OPEN BEFORE Friday, 21st September, 2018 at 12.00 Noon.

2.9 Deadline for Submission of Tenders

Tenders must be deposited at the address specified not later than **Friday**, 21st **September**, 2018 at 12.00 Noon.

The procuring entity may, at its discretion, extend this deadline for the submission of tenders in which case all rights and obligations of the seller and tenderers previously subject to the deadline will thereafter be subject to the deadline as extended.

2.10 Modification of tenders

The tenderer may modify or withdraw its tender after the tender's submission prior to the deadline prescribed for submission of tenders. No tender may be modified after the deadline for submission of tenders

2.11 Opening of Tenders

The Procuring entity will open all tenders in the presence of tenderers' representatives who choose to attend at 12 Noon, Friday, 21st September, 2018 and in the location specified in the invitation to tender. The tenderers or representatives who are present shall sign a register evidencing their attendance.

2.12 Clarification of tenders

To assist in the examination, evaluation and comparison of tenders the Procuring entity may, at its discretion, ask the tenderer for a clarification of its tender. The request for clarification and the response shall be in writing, and no change in the prices or substance of the tender shall be sought, offered, or permitted.

2.13 Evaluation and Comparison of Tenders

The Procuring entity will evaluate and compare the tenders, which have been submitted to determined their responsiveness within 15 days of the validity period from the date of opening the tender.

Any effort by the tenderer to influence the Procuring entity in the Procuring entity's tender evaluation, tender comparison or contract award decisions may result in the rejection of the tenderers' tender.

2.14 Award Criteria

The Procuring entity will award the contract to the successful tenderer(s) whose tender has been determined to be substantially responsive and has been determined to be the highest evaluated tender, subject to the reserves price. If the highest evaluated tenderer is unable for whatsoever reason to enter into a contract with the procuring entity, the Procuring entity will award the contract to the tenderer(s) whose tender has been determined to be substantially responsive and has been determined to be the second highest evaluated tender, subject to the reserves price, and so on.

2.15 Notification of Award

Prior to the expiration of the period of tender validity, the Procuring entity will notify the successful tenderer(s) in writing that its tender has been accepted.

Simultaneously the other tenderers shall be notified that their tenders have been unsuccessful.
