Please note the change in World Aquatics Bylaw 14.2 as communicated on 12 July 2022 (copy enclosed) which provides as follows:

BL 14.2 Members of the FINA Members, in particular clubs, shall only be able to exercise their voting rights at the general meetings of the FINA member to which they are affiliated if they comply with the following conditions:

- i. It shall have a minimum of 10 athletes affiliated to it;
- ii. It shall participate in national championships and other national Aquatics competitions recognised and/or organised by the FINA member to which it is affiliated;
- iii. It shall pay its annual membership fee set by the FINA member to which it is affiliated and comply with all other financial obligations; and
- iv. It shall fully comply with the rules enshrined under FINA Rule C.8, notably complying with and implementing decisions taken by FINA (notably taken by the Congress, the Bureau, the Executive or/and judicial panels) and the FINA member to which it is affiliated, as well as supporting FINA and the FINA member to which it is affiliated in their efforts to achieve their objectives.

The Chairman of an eligible Member should confirm attendance and indicate in writing two (2) Delegates (i.e. the Voting and Non-Voting Delegate) **NOT LATER Monday, 6 March 2023**. Written notifications of the Delegates should be via the Federation's Email, at address <u>ugandaswimmingfed@gmail.com</u>.

Members are reminded to settle USF Affiliation Fees (Members', Athletes' and Coaches' Fees) and any arrears due to the USF not later than **Monday, 6 March 2023**, and can reach the Treasurer on **0772 982 635**
