Under no circumstances shall Tick'it team be liable for any direct, indirect, special, incidental or consequential damages, including, but not limited to, loss of data or profit, arising out of the use, or the inability to use, the materials on this site, even if Tick'it team or an authorized representative has been advised of the possibility of such damages. If your use of materials from this site results in the need for servicing, repair or correction of equipment or data, you assume any costs thereof.

Tick'it will not be responsible for any outcome that may occur during the course of usage of our resources. We reserve the rights to change prices and revise the resources usage policy in any moment.

Will not provide any services or products to any Office of Foreign Assets Control (OFAC) sanctioned countries in accordance with UAE Law.

Governing Law and Jurisdiction, any purchase, dispute or claim arising out or in connection with this website shall be governed and constructed in accordance with the law of UAE.

License

Tick'it grants you a revocable, non-exclusive, non-transferable, limited license to download, install and use the app strictly in accordance with the terms of this Agreement.

These Terms & Conditions are a contract between you and Tick'it (referred to in these Terms & Conditions as "Tick'it", "us", "we" or "our"), the provider of the Tick'it website and the services accessible from the Tick'it website (which are collectively referred to in these Terms & Conditions as the "Tick'it Service").

You are agreeing to be bound by these Terms & Conditions. If you do not agree to these Terms & Conditions, please do not use the Tick'it Service. In these Terms & Conditions, "you" refers both to you as an individual and to the entity you represent. If you violate any of these Terms & Conditions, we reserve the right to cancel your account or block access to your account without notice.

Definitions and key terms

To help explain things as clearly as possible in this Terms & Conditions, every time any of these terms are referenced, are strictly defined as:

• Cookie: small amount of data generated by a website and saved by your web browser. It is used to identify your browser, provide analytics, remember information about you such as your language preference or login information.

• Company: when this policy mentions "Company," "we," "us," or "our," it refers to Tick'it SAL, 440 Dimitri Hayek Street, Sin El Fil, LEBANON that is responsible for your information under this Terms & Conditions.

• Country: where Tick'it or the owners/founders of Tick'it are based, in this case is Lebanon

• Device: any internet connected device such as a phone, tablet, computer or any other device that can be used to visit Tick'it and use the services.

• Service: refers to the service provided by Tick'it as described in the relative terms (if available) and on this platform.

• Third-party service: refers to advertisers, contest sponsors, promotional and marketing partners, and others who provide our content or whose products or services we think may interest you.

Restrictions

You agree not to, and you will not permit others to:

Order processing

Tick'it provides a simple process for accepting orders for tickets on our website or user app. It gives you a wide choice of payment methods.

"Pay with Card" payment method include a credit card gateway. All payment information is transferred via a Secure Socket Layer (SSL).

"Pay in cash" payment method only for Lebanon, Point of Sale all Bob Finance Branches and "At The Door" of the event.

Each of the payment methods mentioned above has its own additional service charges that are a surcharge to the ticket price as disclosed on the relevant payment page.

Buying tickets

The Buyer purchases tickets for the event and pays by one of the supported payment methods. A Processing fee is charged on each ticket that is either borne by the Organizer or the Buyer as disclosed in the order form.

Value Added Taxes, if any, are included in the ticket price.

The Organizer reserves the right to modify the ticket prices from time to time. In any case, if the amount the customer pays for a ticket is incorrect regardless of whether because of an error in a price posted by the Organizer or otherwise communicated to the customer, or the customer was able to order a ticket before its scheduled sale or presale date or the customer was able to order a ticket that was not supposed to have been released for sale, then the Organizer (or the order for that ticket) will refund to you the amount that you paid. This will apply regardless of whether because of human error or a transactional malfunction of Tick'it or the Organizer.

Purchase Confirmation

If the customer does not receive a confirmation e-mail after submitting payment information, or if the customer experiences an error message or service interruption after submitting payment information, it is the customer sole responsibility to confirm with the Organizer whether or not the order has been placed. If the buyer believes that an order was or was not placed because he/she failed to receive confirmation. All ticketing inquiries must be made by e-mail to <u>support@tickit.co</u>

Tickets

The customer can retrieve their tickets from the purchase confirmation we send by email, or from the same account through the Tick'it user app. Tickets can be exported in pdf format or printed for access at the event. These tickets contain a unique QR code(s) that correspond to the customers' order and must be brought to the event in either printed or electronic format to gain access to the event.

Some events might require identification and the customer will be asked to produce some form of ID to prove their identity, without which they might not be admitted to the event.

At the event, there will only be one entry per ticket. If there are multiple parties attempting to enter using the same ticket, only the first party that arrived with the ticket will be admitted. Please consult the event description for full details.

Event Restrictions

When you enter your ticket to the resale queue, Tick'it users are given the opportunity to purchase that ticket. Not all resale tickets that go on sale are sold.

The customer will be able to add his ticket for resale at any time after the purchase. Resale pool opens for a ticket once this specific ticket type sells out. In that case, You can resell your ticket via the Tick'it mobile app. Once you confirm that you want to resell your ticket, your ticket will be added to the resale pool list in order and will remain pending till the ticket type sells out. Once it does, tickets from the resale pool will start being sold. Make sure you remain patient and wait for your turn on the resale list.

To avoid ticket cancellation at the event, we highly advise you not to external resale services.

If your ticket does not sell when entered into resale, you will not be given a refund for the ticket.

If your ticket resells Tick'it will only refund the face value of the ticket. Any booking or payment processing fee will not be refundable. Where there has been no separate booking fee charged with your ticket purchase, Tick'it shall deduct a reasonable administrative fee from the ticket price when processing your refund. Your ticket will be sold at the final price point for tickets of the type that you purchased.
