

Privacy Policy

Syntim built the HypnoTidoo app as a Freemium app. This page is used to inform visitors regarding our policies with the collection, use, and disclosure of Personal Information if anyone decided to use our Service.

If you choose to use our Service, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

Information Collection and Use

For a better experience, while using our Service, we may require you to provide us with certain personally identifiable information, including but not limited to name, email. The information that we request will be retained by us and used as described in this privacy policy.

The app does use third party services that may collect information used to identify you.

Log Data

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol (“IP”) address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.

Cookies

Auto-renewing subscription

- *Monthly Subscription* (Trial period: first 7 days free)

Length of subscription

- *Annual subscription* : The purchase of an *Annual subscription* allows access to the entire library for a period of 12 months, with automatic renewal of the subscription if no disengagement is made by the user.

- *Monthly subscription*: The subscription to a *Monthly subscription* allows access to the entire library for a period of 1 month, with automatic renewal of the subscription if no disengagement is made by the user.

Price of subscription

- *Annual subscription* : € 59.99 / year (€ 4.99 / month)
- *Monthly subscription* : € 6.99 / month
