You can reschedule your scheduled installation 48 hours ahead of your scheduled installation, anything later than that then the Site will charge you with a PHP 500 rescheduling fee.

INSTALLATION SCHEDULE NO SHOW and TARDINESS

In the event that you came in late to you scheduled installation or pick up, the tire dealer will try to accommodate you the best they can. But they reserve the right to ask you to reschedule your appointment through the Site where you will be charged PHP 500. Refer to the **RESCEDULING OF TIRE INSTALLATION** section of this document.

In the event that you failed to show up to your scheduled installation, you will be asked to reschedule your appointment through the Site where you will be charged PHP 500. Refer to the **RESCEDULING OF TIRE INSTALLATION** section of this document.

INSTALLATION OF TIRES

The Tire/s purchased will only be installed to the vehicle stated in the order confirmation. We will use the vehicle make, model, year and plate number to determine this. We will also require a proof of identification and the emailed order confirmation. Please bring your Philippine Driver's license or any government ID plus your order confirmation that is emailed to you.

The Tire dealer reserves the right to decline service if you were not able to prove the purchase. This is a measure we have put in place to protect you and our tire dealers.

WARRANTRIES

The tires sold in the Site are covered by the manufacturer's warranty. The tire dealer will process any claim of warranty.
