

All the Diploma and PDIS Institutions are requested to complete uploading of Examination Registration/ Form fill up data of the above Semesters by the scheduled dates. After closure of Examination Registration/ Form fill up of without fine category and also, after closure of Examination Registration/ Form fill up with fine category, demand notes shall be generated by the system separately. Institutions must complete payment of examination fees against the corresponding demand notes by the last date of making online payment. Failure to make online payment by the last date stipulated for the purpose shall make the entries of Examination Registration/ Form fill up data invalid and such students shall not be eligible to appear in the ensuing examination.


*The examination registration of regular students is subject to satisfying eligibility criteria based on attendance of classes which shall be determined after closing of attendance. Those students who will be found ineligible on attendance criteria shall not be able to appear in the Examination of corresponding Semester. The Portal shall be opened for entry of eligibility to appear in the examination, based on class attendance, after closing of attendance.*
