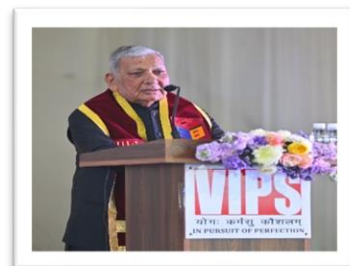

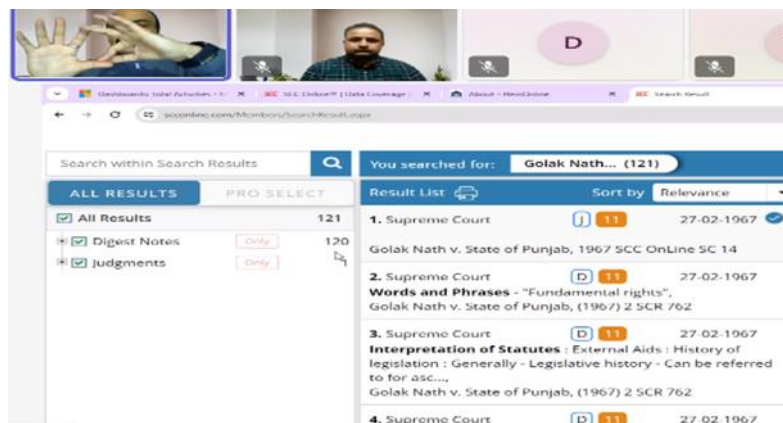

LEXCOM, VSLLS Organized Symposium on Corporate Social Responsibility (CSR)

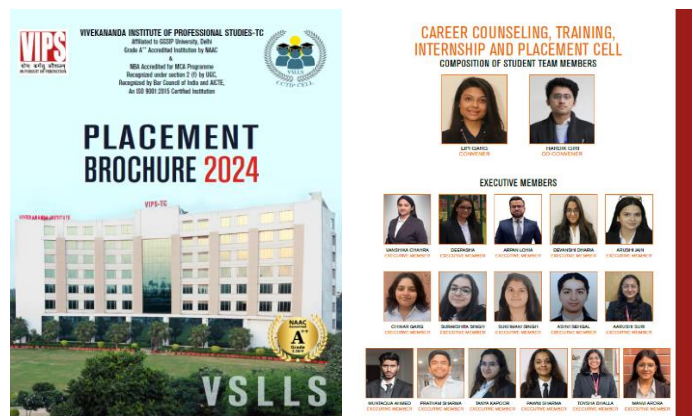

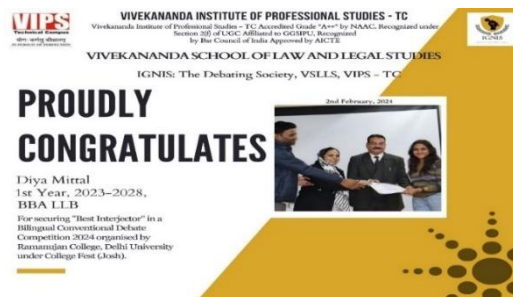

12 January: National Youth Day

Swami Vivekananda Jayanti, commemorated on 12 January, honors the birth of Swami Vivekananda, born in 1863. Designated as Rashtriya Yuva Diwas, it draws inspiration from his profound philosophy. He, the chief disciple of mystic Ramakrishna Paramhansa, founded the Ramakrishna Math and the global Ramakrishna Mission, rooted in Vedanta philosophy. The day pays homage to Vivekananda's teachings, advocating for youth participation in the modern world while upholding values. Noteworthy for his impact on modern Hinduism and inspiring nationalist leaders during colonial rule, Vivekananda's famous 1893 speech in Chicago introduced Hinduism to the Western world. His influence extends to India's fight against colonial rule, with leaders like Subhas Chandra Bose and Mahatma Gandhi acknowledging his profound impact. The theme of this year's festival is "*Viksit Bharat@ 2047: Yuva ke liye, yuva ke dwara*". National Youth Day, initiated in 1985, witnesses nationwide celebrations at schools and colleges, featuring processions, speeches, music, conventions, seminars, Yogasanas, essay competitions, and sports.

Domestic Legal News

Arbitral awards are not subject to modification according to Sections 34 and 37 of the Arbitration and Conciliation Act: Supreme Court

5 January 2024: While deciding on a plea whether there is a scope of interference with arbitral awards under Section 34 and 37 of the Arbitration and Conciliation Act, 1996, the Supreme Court has reiterated the settled position of law that any attempt to “modify an award” while adjudicating Sections 34 and 37 petitions is not permissible under the Arbitration and Conciliation Act, 1996.

Supreme Court outlines key considerations for determining remission applications

9 January 2024: the Supreme Court not only set aside the remission of 11 convicts in the Bilkis Bano case but also provided detailed guidelines for considering remission applications. The top court highlighted key factors that must be taken into account, offering an illuminating roadmap for evaluating such pleas under the Code of Criminal Procedure. The judgment emphasised that remission applications under Section 432 of the CrPC must be directed to the government of the state within whose territorial jurisdiction the applicant was convicted, known as the “appropriate government”. Furthermore, the convict or someone acting on their behalf must submit the application, ensuring compliance with Section 433A, which mandates that a person serving a life sentence can seek remission only after completing fourteen years of imprisonment. Additionally, it outlined specific tests for judicial review when an application for remission, ensuring that the process remains fair, transparent, and free from arbitrariness.

Children born from a void marriage cannot be deprived of their rightful share in their parent's property: Supreme Court

20 January 2024: The Supreme Court held that the children born out of a void and voidable marriage shall be considered as legitimate children and be treated as an extended family of the common ancestor for the purpose of deciding a valid share in the property of the common ancestor. It was held that once the common ancestor has admittedly considered the children born of void and voidable marriage as his legitimate children, then such children would be entitled to the same share as the successors in the property of the common ancestor as that of children born out of a valid marriage.

Supreme Court upholds that Bail Cannot Be Cancelled Merely Due to Non-Appearence of Accused Before Court

29 January 2024: The Supreme Court recently observed that the non-appearance of the accused party is no ground for cancellation of bail. The Court observed that if bail has been granted, the same can be cancelled if any conditions are violated or liberty is misused.

Breaking Up and Advising Partner to Marry Someone Else Won't Amount to Abetment to Suicide: Supreme Court

12 February 2024: The Supreme Court observed that merely advising a partner to marry as per the advice of parents would not attract the penal provisions of abetment to suicide under Section 306 of the Indian Penal Code. "Broken relationships and heartbreaks are part of everyday life. Hence the offence under Section 306 is not made out." The bench comprising Justices Vikram Nath and K.V. Viswanathan observed that the instigation to commit suicide must be continued and should create circumstances for committing suicide. There must be direct or indirect acts of incitement to the commission of suicide. The accused must be shown to have played an active role by an act of instigation or by doing certain acts to facilitate the commission of suicide.

Electoral Bonds Scheme struck down as unconstitutional by the Supreme Court

15 February 2024: The Supreme Court delivered its judgement in the electoral bonds case, holding that anonymous electoral bonds are violative of the right to information under Article 19(1)(a) of the Constitution. Accordingly, the scheme has been struck down as unconstitutional. A constitution bench comprising Chief Justice DY Chandrachud, and Justices Sanjiv Khanna, BR Gavai, JB Pardiwala, and Manoj Misra heard a batch of cases challenging the controversial electoral bonds scheme. "Information about funding of political parties is essential for the effective exercise of the choice of voting." Chief Justice Chandrachud stressed right at the outset, emphasising the importance of open governance. SBI has been directed to give details of electoral bonds purchased within 3 weeks and to herewith stop the issuance of electoral bonds.

Supreme Court Rules Directors Not Responsible for Bounced Cheques Issued by Company Post-Resignation under N.I. Act

16 February 2024: The SC has observed that the director could be held liable for the dishonour of the cheque after his retirement only when it is proved that any act of a company is proved to have been done with the connivance or consent or may be attributable to a director.

Supreme Court Proposes Declaring Chandigarh Mayor Election Results Based on Present Votes Instead of Fresh Election

19 February 2024: The Court stated that it would direct that the votes already cast be counted by disregarding the marks which were made on them by the previous Presiding Officer Mr. Anil Masih. The Court stated that it will ask the Deputy Commissioner of the Chandigarh Administration to nominate an officer, who is not aligned with any of the political parties, to be the returning officer to count the ballots and declare the results. A bench comprising the CJI, Justices JB Pardiwala and Manoj Misra directed that the ballot papers be produced before the Court to ascertain if the votes can be deduced from them. The Court then stated that it would order the counting based on the present ballots. The Registrar General of the High Court has been asked to nominate a judicial officer to bring the ballot papers to the Court.

Supreme Court upholds Termination of Women Officer on Ground of Marriage as Arbitrary

19 February 2024: In a case where a woman nursing officer was terminated from the Military Nursing Service on the grounds of marriage, the Supreme Court firmly termed the same to be a 'coarse case of gender discrimination and inequality'. The Division Bench of Justices Sanjiv Khanna and Dipankar Datta also reiterated that rules, on the basis of which such women officers were terminated because of their marriage, are unconstitutional.

Supreme Court overturns its 2018 decision which set a time limit on Court's stay orders

29 February 2024: In 2018, a three-judge bench comprising Justices Adarsh Goel, Navin Sinha and Rohinton Nariman were deciding a batch of cases involving the Prevention of Corruption Act. These batches of cases had one aspect in common – that the respective High Courts had granted a stay at some stage of trial. A five-judge bench, overturning the 2018 judgement, held that constitutional courts should refrain from laying down precise timelines for deciding cases, highlighting the discretion that should be afforded to lower courts which are more aware of

“grassroots issues”. The SC also pointed out that courts often have different patterns when it comes to their pending caseload, and so the concerned court is best placed to decide which cases to prioritise.

Supreme Court Issues Guidelines on Exercise of Inherent Powers under Article 142

29 February 2024: A Constitution Bench has held that Article 142 of the Constitution confers wide-ranging powers on the highest court of the land to pass orders and decrees necessary to ensure ‘complete justice’ in any case before it. These orders are enforceable throughout India and can include directives for the attendance of individuals, discovery of documents, or investigation of contempt of court. Importantly, the constitution bench also held that the Supreme Court’s powers under Article 142 cannot be exercised to defeat the principles of natural justice, which are an integral part of our jurisprudence.

International Legal News

ICJ orders Israel to prevent acts of genocide in Gaza

26 January 2024: The International Court of Justice (ICJ) has delivered its ruling on the emergency measures requested by South Africa in its genocide case against Israel over its war on the Gaza Strip. The court said, among others, that Israel must take steps to prevent acts of genocide in Gaza but stopped short of ordering a ceasefire. The judges have not ruled on the merits of the genocide allegations, which may take years to decide. Since October 7, Israel’s military campaign has killed at least 26,083 people and wounded 64,487 others, according to officials in Gaza. Thousands more are missing under the rubble, most of them presumed dead. The ruling fell short of ordering a ceasefire in the Gaza war. Various nations, including South Africa, Germany, the EU, and Turkey, have called on Israel to adhere to the measures. The ICJ’s decision stems from an application by South Africa, and while the Court has not yet conclusively determined whether Israel committed genocide, it indicates a plausible risk under the 1948 Genocide Convention.

ICJ Rules that Russia Violated Anti-Terrorism and Anti-Racial Discrimination Treaties in 2014 Ukraine Annexation

31 January 2024: the ICJ has ruled that Russia breached global anti-terrorism and anti-racial discrimination treaties in connection to its 2014 annexation of parts of Ukraine. However, the ICJ rejected many of the charges brought by Kyiv. The Court found Russia in violation for not

investigating information from Ukraine about individuals supporting terrorism. The Court ruled that Russia has committed a violation set forth in Article 2 of the International Convention for the Suppression of the Financing of Terrorism. Regarding Crimea, Russia was ruled to have violated the Convention on the Elimination of Racial Discrimination in its educational system implementation related to Ukrainian language curricula. Additionally, Russia breached its obligation under the ICJ's provisional measures issued in 2017, which required refraining from actions that could worsen the dispute.

ICJ holds public hearings in the advisory proceedings on the Legal Consequences arising from the Policies and Practices of Israel in the Occupied Palestinian Territory

21 February 2024: An unprecedented number of countries and international organizations participated in the International Court of Justice's (ICJ) oral hearings on Israel's occupation beginning February 19, 2024. The oral proceedings stem from a December 2022 request by the United Nations General Assembly for an advisory opinion by the court on the legal consequences of Israel's policies and practices in the Occupied Palestinian Territory. The court has the opportunity to address the prolonged occupation, to consider Israel's practices and policies violating international legal prohibitions against racial discrimination, including the crimes against humanity of apartheid and persecution, and to appraise the legal responsibilities of other countries and the UN to address violations of international law arising from the occupation.
