Charter titled ‘Responsible Use of AI’, first to be adopted in India by VIPS-TC and proposed for adoption by other academic institutions, authored by Dr. Karnnika A. 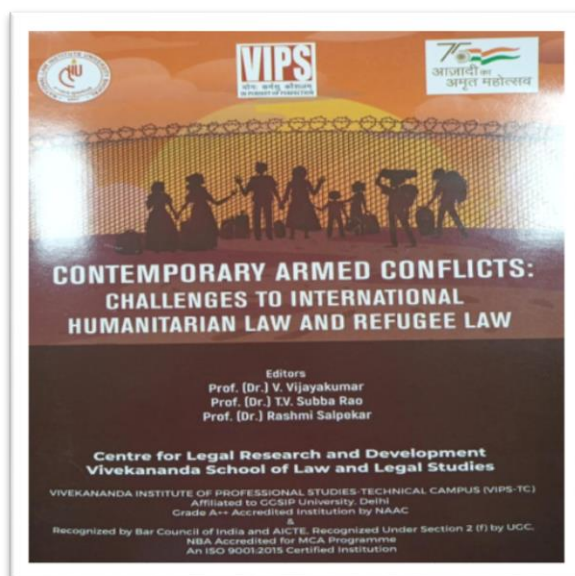

VSLLS LLM(Corporate) Students Visit to National Company Law Appellate Tribunal, New Delhi (NCLAT)



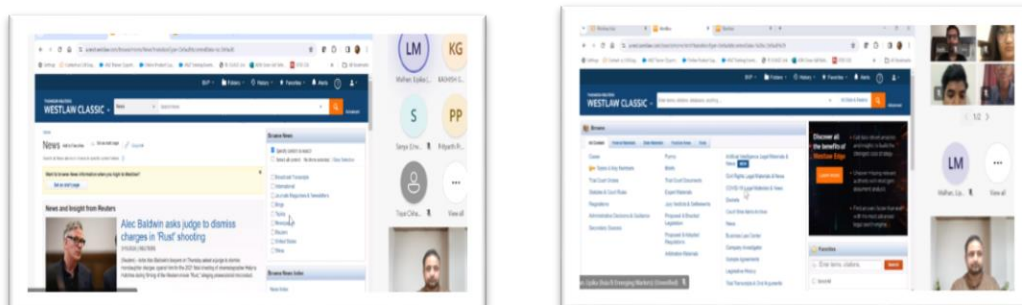

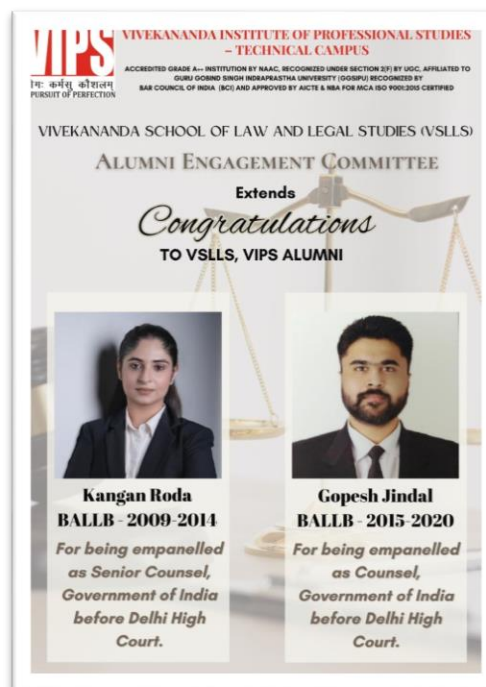

VSLLS Students adjudicated as Semi-Finalists at NLIU-INADR International Mediation Tournament, 2024

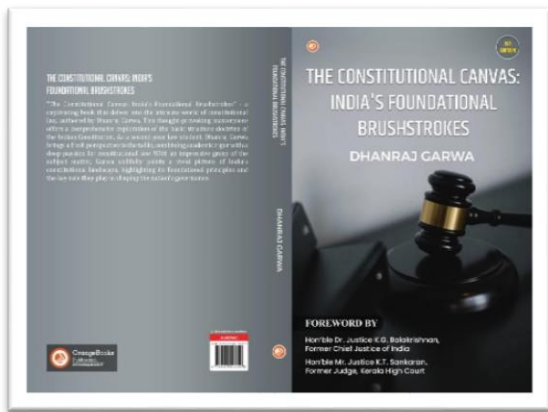

1 MARCH: ZERO DISCRIMINATION DAY



Each year on March 1, the United Nations and international organizations observe Zero Discrimination Day, promoting equality under the law. This global effort, initiated in 2014 by UNAIDS Executive Director Michel Sidibé, aims to eradicate all forms of discrimination and highlights the barriers it creates, hindering access to education, healthcare, and job opportunities. The 2024 theme, "To protect everyone's health, protect everyone's rights," emphasizes the connection between human rights and public health in ending AIDS by 2030.

In a recent statement, UN Chief Antonio Guterres urged reparations to address the lasting impact of transatlantic slavery, citing systemic racism today. He emphasized the need for reparatory justice to overcome generations of discrimination. The movement for reparations has gained global momentum, with initiatives like the CARICOM commission seeking redress from former colonial powers. Verene Shepherd of the University of the West Indies called on colonial powers to acknowledge their responsibility in addressing the consequences of slavery.

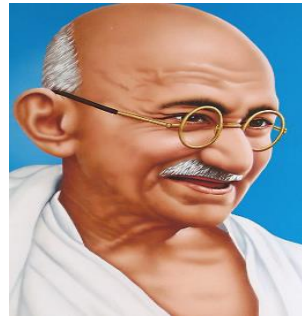

Domestic Legal News

Supreme Court overrules a 25-year-old precedent to deal with the ambit of parliamentary privileges

4th March, 2024: The Apex Court declared that Members of Parliament (MPs) and Members of Legislative Assemblies (MLAs) cannot claim immunity from prosecution for taking payments to vote or deliver a speech in the House in a specific manner. Seven-judge Constitution Bench, chaired by Chief Justice of India (CJI) D.Y. Chandrachud, unanimously reversed its 1998 decision in P.V. Narasimha Rao v. State and allows law enforcement authorities to file bribery charges against parliamentarians under the Prevention of Corruption Act 1988.

Supreme Court acts on the Protection Petition of LGBTQ+ Couples while Discussing the Concept of Family

11th March, 2024: The Supreme Court has delivered a significant judgment regarding habeas corpus writ petitions and police protection pleas filed by couples, often facing societal stigma and fear of life from families. The court found that such directives may afflict members of the LGBTQ+ community and have deterring consequences and therefore issued recommendations to emphasise the need for queer-sensitive behaviour while also addressing the difficulties and societal stigma that inter-caste and inter-faith couples confront.

SBI Directed by the Supreme Court to Disclose All Electoral Bond Data

15th March, 2024: The Supreme Court directed the State Bank of India to give all details, including alphanumeric and serial numbers, of bonds acquired after April 11, 2019, and the Election Commission of India was instructed to swiftly upload this information once received and to present all 'conceivable' details available with it regarding electoral bonds, that includes the alphanumeric number corresponding to each bond.

Factors to Determine the Term of Sentence Convicts Must Undergo Before Remission in Murder Cases Summarised by Supreme Court

21st March, 2024: The Supreme Court summarised the elements considered when determining the length of sentence offenders must serve before requesting remission in murder cases including the extent of the injuries, the number of deceased victims, the accused's criminal history, and whether the offence was done while on bail. The court also cited favourable aspects such as the accused's age, potential for rehabilitation, and repentant behaviour.

Preventive Detention is Not to be Invoked merely on the Grounds of the State Police's Inability to Maintain Law and Order

21st March,2024: The Supreme Court bench comprising Chief Justice DY Chandrachud, Justice JB Pardiwala, and Justice Manoj Misra underlined preventative detention as a severe policy. They highlighted that any order of detention based on an arbitrary or routine exercise of powers must be overturned at the first available threshold. Further, the court summarized the ambit of preventive detention and held that the inability of police machinery to maintain law and order is no excuse to invoke jurisdiction of preventive detention.

Corporate Entities Permitted to File Consumer Complaints Under Consumer Protection Act 1986: Supreme Court

23rd March,2024: The Supreme Court ruled that under the Consumer Protection Act of 1986, a corporate organisation can be recognised as a 'person' when filing a consumer complaint demanding an insurance amount. The court noted that, while the Act does not directly include corporate entities in the definition of 'person', the meaning is comprehensive and includes corporate entities as well.

INTERNATIONAL LEGAL NEWS

Nicaragua Files Case Against Germany at ICJ Over Israel Aid and UNRWA Funding

2nd March, 2024: Nicaragua has filed a case at the International Court of Justice (ICJ) accusing Germany of facilitating "genocide" in Gaza. The Nicaraguan government alleges that Germany's provision of financial and military aid to Israel, coupled with halting funding for the United Nations agency for Palestinian refugees (UNRWA), amounts to complicity in genocide. The filing draws parallels with a separate case filed by South Africa, accusing Israel of committing genocide against Palestinians in Gaza. Nicaragua invokes the 1948 Genocide Convention and the 1949 Geneva Conventions, asserting that Germany's actions violate international law.

ICC: Arrest Warrants for Russian Commanders Over Alleged War Crimes in Ukraine

5th March,2024: the International Criminal Court (ICC) issued arrest warrants for Russian commanders Sergei Kobylash and Viktor Sokolov, alleging their involvement in war crimes in Ukraine, particularly targeting electric infrastructure from 10th October, 2022 to 9th March, 2023. These warrants, issued a second time in relation to the conflict, follow a pattern of alleged attacks on Ukrainian civilians and infrastructure by Russian forces. While Ukraine's President

Volodymyr Zelenskyy welcomed the ICC's decision, Russia has denied targeting civilian infrastructure deliberately, insisting its actions aim to limit Ukraine's military capabilities.

South Africa submits an urgent request for the indication of additional provisional measures and the modification of the Court's prior provisional measures Order and decision in South Africa v. Israel

6th March,2024: South Africa filed an urgent request with the Court for the indication of additional provisional measures and the modification of the Court's Order in the case concerning Application of the Convention on the Prevention and Punishment of the Crime of Genocide in the Gaza Strip (South Africa v. Israel). It requests the Court to indicate further provisional measures and/or to modify the provisional measures indicated in its Order of 26 January 2024, pursuant to Article 41 of the Statute of the Court in order urgently to ensure the safety and security of 2.3 million Palestinians in Gaza, including over a million children.

The decision to look into alleged crimes against humanity in Venezuela was upheld by the International Criminal Court

20thMarch,2024: Despite Venezuela's strong protests, the Appeals Chamber of the International Criminal Court (ICC) has upheld its previous ruling to move forward with an investigation into possible crimes against humanity perpetrated by the government of that nation. This ruling is a major step forward in the continuing legal dispute between Venezuela and International Criminal Court.

First Artificial Intelligence Act Passed by European Union

22nd March,2024: The AI Act is the first full framework of rules for artificial intelligence regulation in history. AI applications are classified by the Act using a risk-based methodology, which is intended to serve as a defence against the possible threats presented by quickly developing technology. It makes a distinction between AI systems that pose a low or high risk, each of which is regulated and scrutinised differently.
