


Professional Skill Development Activity for Students at VSLLS, VIPS-TC





#### 1<sup>st</sup> MAY: INTERNATIONAL LABOUR DAY



International Workers' Day, also known as Labour Day in some countries and often referred to as May Day, is celebrated annually on May 1 or the first Monday in May. It honors labourers and the working class, promoted by the international labor movement.

Foreign businesses in India face challenges understanding and calculating minimum wages due to state-specific variations and classifications based on region, industry, skill level, and job nature. Minimum wages are set using a complex system covering nearly 2,000 job types for unskilled workers and over 400 employment categories,

including the variable dearness allowance (VDA) linked to inflation and, where applicable, the house rent allowance (HRA). Workers are categorized as unskilled, semi-skilled, skilled, and highly skilled, requiring regular updates to wage rates.

India's minimum wage regulation, governed by the Minimum Wages Act, 1948, will soon be replaced by the Code on Wages Act, 2019. This new code will consolidate and update existing labor laws, mandating regular wage reviews by central and state governments. Additionally, India aims to establish a 'living wage' by 2025, in collaboration with the International Labour Organization (ILO), to cover essential social expenditures beyond the basic minimum wage.

#### **Domestic Legal News**

#### Supreme Court Opined Reproductive Freedom is a Fundamental Right of a Person

29 April 2024: In the issue of medical termination of pregnancy, the Apex Court bench of CJI D.Y. Chandrachud, Justice J.B. Pardiwala, and Justice Manoj Misra said that reproductive freedom is a fundamental right. The Court's decision used the word "pregnant person" rather than "pregnant lady" CJI DY Chandrachud, specified that the term "pregnant person" not only recognizes cisgender women, but pregnancy can also be experienced by some non-binary people and transgender men, among other gender identities.


#### Supreme Court Held That 3 Month Deadline for Juvenile Preliminary Assessments Is Directory and Not Mandatory

07 May 2024: The Supreme Court bench of Justices C T Ravikumar and Rajesh Bindal explained that Section 14(3) of the Juvenile Justice (Care and Protection of Children) Act, 2015, which provides for a three-month preliminary examination of a Child in Conflict with Law, is not necessary.

#### Service Provider to prove the commercial nature of service not complainant under Consumer Protection Act

10 May 2024: In the case of *Shriram Chits (India) Private Limited v. Raghavchand Associates* ruled that the responsibility to prove service was obtained for commercial purposes under the Consumer Protection Act, 1986 lies with the service provider, not the consumer. The court emphasized that the Act is consumer-friendly and beneficial, and cannot burden consumers to prove a service was not for commercial purposes.

14 May 2024: The Hon'ble Apex Court overruled a 2007 judgment of the National Consumer Disputes Redressal Commission's decision in *D.K. Gandhi PS v. M. Mathias* and has ruled that advocates cannot be held liable for alleged deficiency in services under the Consumer Protection Act, 1986, as re-enacted by the Consumer Protection Act 2019 under Section 2 (o).

#### Supreme Court held that CrPC is not applicable retrospectively before 31.10.2019

17 May 2024: In the case of National Investigation Agency New Delhi v. Owais Amin @ Cherry & Ors., the Supreme Court declared that the Code of Criminal Procedure (CrPC) in Jammu & Kashmir will apply only if Article 370 is repealed.

#### **International Legal News**

#### Israel refutes South Africa's accusations at ICJ concerning the Gaza Genocide

17 May 2024: The UN International Court of Justice (ICJ), heard the response from Israel on the case brought forward by South Africa requesting emergency provisional measures to immediately halt Israeli military operations underway in Rafah, in southern Gaza, where over one million Palestinians were sheltering after having been displaced from elsewhere in the enclave.

### International Criminal Court Prosecutor applies for arrest warrants in the situation in the State of Palestine

20 May 2024: The International Criminal Court Prosecutor, Karim Khan, applied for arrest warrants to be issued against three Hamas leaders and the Israeli Prime Minister and Defence Minister for what he describes as war crimes and crimes against humanity. Although the ICC is not a UN organization, it has an agreement of cooperation with the United Nations. When a situation is not within the court's jurisdiction, the UN Security Council can refer the situation to the ICC, granting it jurisdiction.

## International Tribunal for Law of the Sea advises countries are legally required to reduce greenhouse gas emissions

21 May 2024: The International Tribunal for the Law of the Sea (ITLOS) defined greenhouse gas (GHG) emissions as a form of marine pollution under the UN Convention on the Law of the Sea in a landmark advisory opinion released Tuesday. The opinion, a response to inquiries by Antigua, Barbuda, Tuvalu, and the Commission of Small Island States on Climate Change (COSIS), asserts that nations are legally bound to curb emissions to safeguard the marine environment.

#### ECHR rules against Bulgaria in forfeiture of criminal assets and high court fees case

22 May 2024: The European Court of Human Rights (ECHR) ruled on Tuesday against Bulgaria in *Mandev and Others v. Bulgaria*, a case relating to unfair and unjustified forfeiture of assets as proceeds of crime and high court fees. The court ruled a violation of Article 1 of Protocol No. 1 of the European Convention on Human Rights. The court's ruling was based on the precedent case of Todorov and Others v Bulgaria in 2021.

#### EU officially approves world's first landmark AI legislation

22 May 2024: The European Union (EU) officially approved the world's first landmark AI legislation. The Council of the European Union unanimously adopted the Artificial Intelligence (AI) Act, which will enter into force 20 days after publication in the EU's official journal. AI Act ensures that artificial intelligence adheres to vital EU legislations including Article 2 and Article 6 of the Treaty on European Union and the Charter.
